Dear Sirs and Madams.

I appreciate that you are dealing with an issue which you see as complex and you suffer having to work in the context of a social environment mislead by self-righteous greed based propaganda, however, please consider the following.

Ever since the European settlement into Australia the European concept of **Greed Conquers All** has ruled. With the military power and organisation to do so and zero humanity the settlers treated the native people as a nuisance to be dispossessed, removed, exploited, murdered as required purely to satisfy self-righteous greed.

Far too slowly, we have recognised that this behaviour is not acceptable and that, just because the original owners did not have a formal land title system, that did not mean that they weren't the effective owners of the land. Despite the fact that the culture of the 'rulers' in Queensland has always supported repression as a first principal, it's time to move away from that approach.
