# Foreword

The Commission of Inquiry into Abuse of Children in Queensland Institutions (Forde Inquiry) highlighted the importance of providing former residents of institutions with information about their time in care. This information gives people a better sense of their identity, by adding to the story of their past and aspects of their family history.

The Queensland Department of Families is committed to providing former residents with information about themselves. *Missing Pieces* is one of the strategies in place to meet this commitment.

Many former residents have been frustrated in their search for information about their past. Sometimes they are not aware of what records exist or who to contact to get access to records.

This publication is designed to assist former residents by providing information about the records of institutions that have been located to this date. It was first published in 2001 and due to ongoing demand, was updated and reprinted in 2002.

Many of the institutions listed in this guide no longer exist, and, in many cases, the historical records are no longer available. Some information has simply been destroyed or lost over time. While there will always be some missing pieces, this guide attempts to provide a comprehensive listing of the records of departmental institutions and those operated by church and community groups.

The information in this guide has been produced with the assistance of church and community groups and I thank those non-government organisations that have helped in the search for records.

I am pleased to present the second edition of *Missing Pieces* to former residents of Queensland institutions and sincerely hope that it assists them in putting the pieces of their life story together.

# USING THE INFORMATION IN **Missing Pieces**

*Missing Pieces* is divided into two main sections

**1**

Information about records relating to institutions operated by the State Children Department (later known as the Children's Services Department and now known as the Department of Families)

and

**2**

Information about records relating to institutions operated by the non-government sector such as churches and community groups



## Departmental Institutions

The material about the institutions operated by the Department focusses on the four types of records that may exist for each institution:

- client files
- institution files relating to clients
- administrative records and
- the institution's operational registers.

For each of these types of record, there is a description of the record, access conditions, location of the records and who to contact to access the records.

The departmental institutions are listed in alphabetical order. For each institution, there is a brief historical summary and an indication of what types of records are available. Where operational registers exist, there is a description of the information that is generally available in the registers.

Former residents should be aware that many record sets are incomplete.



## Non-government Institutions

This section of the report also lists the institutions in alphabetical order. Extensive cross-references have been included to assist in locating the information. A brief historical summary is provided for each institution.

Church and community groups have provided information on what types of records, if any, they still hold on former residents. Where records exist, there is also an indication of the age range of the material and who to contact.

Please note: Department of Families may have information on former residents of non-government institutions. See the contact details on page 6.

# Departmental Institutions



## RECORDS OF DEPARTMENTAL INSTITUTIONS

The Department has a significant collection of records relating to former clients.

Prior to the 1960s there were only three offices of the State Children Department – Brisbane, Rockhampton and Townsville. Each of those centres also had a Receiving Depot, and there was a youth detention centre in Westbrook. All offices kept their own records, and because decision making was centralised in Brisbane, that office had files on all departmental clients.

Over the last 10 years, regional and area offices have sent their old files to Brisbane for storage. Among these have been records of departmental institutions. All these records have been registered and departmental staff can now search the central office database to determine what records, if any, the Department holds.

The Department has a comprehensive index card system with details on all children who were in care prior to January 1989. A computerised index system was introduced at that time. In many cases, the index card is the only record of a person's admission to care and placements while in care.

When examining institutional records, it is evident that gaps exist in all record series. Circumstances contributing to this situation include:

- strict secrecy provisions in the *Children's Services Act 1965* which prevented disclosure of information
- a culture that did not recognise the importance of these records to former residents, their families, and the community at large
- inconsistencies in record keeping practices from site to site and over time, and
- the destruction of files over the years through factors such as the 1974 Australia Day weekend floods in Brisbane, a fire at Birralea in Rockhampton and, regrettably, unauthorised destruction.

The nature of record keeping has also changed over the years. In the past, most files were created for administrative purposes and did not contain many personal details.

At the present time, the Department maintains over 240,000 files on current and past children in care. The Department has transferred some of the older files to Queensland State Archives. These client records are closed to the public. However, any files at the Archives that relate to individuals who were in care are retrieved from the Archives and provided to them when they apply for their information.

The Queensland State Archives recently advised Department of Families that the Department's client files are to be kept indefinitely.

Departmental information concerning children in care is recorded on four categories of files which date from approx 1910 to the present:

- client files
- institution files relating to clients
- administrative records and
- the institution's operational registers.

## **1** Client Files

**Description:**

Client files relate to children and young people up to the time they were discharged from State care. These children and young people were placed in a variety of situations - some were cared for at home, others in institutions, in foster care or other alternative care arrangements.

A significant number of these records were destroyed in the 1974 Australia Day weekend floods.

The information on the existing files varies, and generally includes reasons why the children and young people came into care (e.g. information about their and their family's circumstances) and placement details. Very few medical details are included in these files.



Until the early 1990s, information about all members of the same family was placed on the same 'family' file. This often means that documents contain personal information about more than one child, or about their parents or other family members.

After the early 1990s, individual files have been kept on each child in care. Where more than one child in a family is placed in care, there is a separate file on each child. However, if a document refers to more than one child, a copy of the document will be placed on each child's file.

To provide an overview of each child's orders and placements, index cards were made for each individual admitted to care from the early 1900s to January 1989, when computerised indexes were introduced. The index cards include a 'family' card as well as a separate card for each individual child of that family who was admitted to care.

The 'family' card includes the names and dates of birth of each child admitted to care and the dates they were admitted and discharged from care. The cards usually also include the parents' names, occupations and religion.

The individual card for each child lists the child's name and date of birth, and date of each 'movement' to an institution or other placement. The cards do not include detailed information about the placements.

**Location:**

Client files are managed by Department of Families in Brisbane. Some earlier files - mostly predating the 1940s - are stored at Queensland State Archives. These client records are closed to the public. However, any files at the Archives that relate to individuals who were in care are retrieved from the Archives and provided to them when they apply for their information.

**Access:**

Although the files are confidential and access is therefore restricted, Department of Families supports the rights of former residents to obtain information about themselves.

The Department is aware that former residents often want the records of their family members and/or other people. This information is often sensitive and personal in nature. To safeguard the rights of privacy, clients are unable to obtain information about other people, including other family members, without the authority of the person/people concerned.

This protects the right to privacy of all individuals, as personal information on other people will be given out only with their permission.

## Institution Files



**Description:**

Some institutions also kept individual client files on children who were placed there.

The information on these files includes details of placement of the child in the institution and when they left, as well as the reason for placement. In some cases detailed information about the child and his/her family is on the file. This can include information about health and family background, as well as educational reports and correspondence. Copies of many documents on the institution file are often included on the Family or Individual file.

**Location:**

These files are generally kept at the institution until after the child is discharged from care, when the file is transferred to Department of Families in Brisbane.

**Access:**

Although the files are confidential and access is therefore restricted, Department of Families supports the rights of former residents to obtain information about themselves.

The Department is aware that former residents often want the records of their family members and/or other people. This information is often sensitive and personal in nature. To safeguard the rights of privacy, clients are unable to obtain information about other people, including other family members, without the authority of the person/people concerned.

This protects the right to privacy of all individuals, as personal information on other people will be given out only with their permission.

## Administrative Records



**Description:**

This series of files provides information about the administration of the institution including its financial and human resources, buildings and equipment. In a number of cases, documents naming some children at the institution are included on the file. These are generally lists of children attending a particular school, or requiring clothing or dental care. The information relating to individual children on these files is rarely of a particularly personal nature.

**Location:**

These files are managed by Department of Families in Brisbane.

**Access:**

Although the files are confidential and access is therefore restricted, Department of Families supports the rights of former residents to obtain information about themselves.

The Department is aware that former residents often want the records of their family members and/or other people. This information is often sensitive and personal in nature. To safeguard the rights of privacy, clients are unable to obtain information about other people, including other family members, without the authority of the person/people concerned.

This protects the right to privacy of all individuals, as personal information on other people will be given out only with their permission.

## Operational Registers



**Description:**

These institutional registers record the day to day operation of the institution and cover a variety of routine activities, as well as specific matters such as disciplinary action, medical treatment and incident reports in relation to residents in the institution. Details of the types of records for each institution can be found in the section on departmental institutions under the name of the institution. For a number of institutions, these types of records are missing. There may also be gaps in the existing records.

**Location:**

This material is managed by Department of Families in Brisbane. Some records are held at Queensland State Archives. These are closed and can be accessed only by the Department.

**Access:**

Although the operational registers are confidential and access is therefore restricted, Department of Families supports the rights of former residents to obtain information about themselves.

The Department is aware that former residents often want the records of their family members and/or other people. This information is often sensitive and personal in nature. To safeguard the rights of privacy, clients are unable to obtain information about other people, including other family members, without the authority of the person/people concerned.

This protects the right to privacy of all individuals, as personal information on other people will be given out only with their permission.

Trust account records	These comprise trust account cards, deposit and receipt books and trust account ledger.

Bed lists	These lists provide information on the number of children resident in the institution, their names, dates of birth and age, gender, whether they were of Aboriginal or Torres Strait Islander descent, area of residence, area office and case worker that had contact with them, admission date, which section they were in, any outstanding court matters, and discharge date.
Bench and summons books	These are copies of the Report on Court Proceedings form which records name and birth date of the child, the reason and the outcome of the court appearance.
Clothing/clothes books	These books record the name of the child, the date and the items of clothing that were provided and whether they were returned.
Clinic reports	This book records the name of the child and the doctor, and the treatment/medicine provided.
Discharge books	These books record the name of the child, date of departure, destination and signature of a staff member.
Discipline books	These books list the names of children who were punished for bad behaviour, the nature of their behaviour, the nature and time frame of the punishment and the name of the staff member who authorised the punishment.
Doctor/specialists books	These books record the names of the child and doctor, and provide information on the type of injury/illness and treatment.
Handcuffs registers	These registers record the name of each child who was escorted from the institution while wearing handcuffs. The date, time, name of escort as well as the time when the handcuffs were removed are also recorded. Each entry was required to be signed by a staff member.



Incidents reports books	Information about incidents includes the name of the child involved, details of the incident including date, time and description of what happened, comments and details of action taken by staff.
Isolation books	The name of the child who was placed in isolation, the reason for the isolation, commencement and conclusion of the isolation period, and names of staff who supervised and authorised the isolation are recorded.
Log books	These books provide a summary of what happened on each shift including the name of staff on duty, names of children and their movements, injuries or incidents.
Leave books	The name of the child and reason for leave are recorded in this register.
Medical report books	These books record the name of the child, the nature of the illness and treatment provided, medication that was prescribed for the child, and when the medication commenced and ceased.
Medication treatment books	These books record admissions and discharges, the number of patients, their names, a brief report on the child and what medication was given.
Non swimmers books	This book has the names of children who did not go swimming and the reason for not swimming.
Observation books	At the end of each shift, staff would record information in these books about each child in a section including medical issues and medication, and a brief description of their behaviour and activities during that shift.
Occurrence books	Information about incidents includes the name of the child involved, details of the incident including date, time and the type of incident.
Orderlies books	For each shift, a report on each child giving information about their behaviour etc. was recorded.
Outfitting books	These books record the name of the child, the date and the items of clothing that were provided and whether they were returned.

Privilege books	These books record the name of a child, and the date and nature of privileges that were given.
Punishment books	These books list the names of children who were punished for bad behaviour, the nature of their behaviour, the nature and time frame of the punishment and the names of staff who administered and witnessed the punishment, as well as the medical officer's signature.
Remand books	This book names the children who were remanded in custody pending a court appearance, and provides a daily report on each child including medical condition and behaviour. Also recorded were the names of children who were admitted and discharged.
Review Books - Serious Offenders Review Panel	The Serious Offenders Review Panel reviewed progress of institution residents who had been found guilty in court of a serious offence. For each young person, there was an initial review, a full case review, progress reviews and a final review.
Rooms 13 and 14 misbehaviour rooms	These 'time out' rooms were used as punishment for misbehaviour. This book records the name of the child, remarks about their misbehaviour, when they went in and came out, and a signature of a staff member.
School roll books	These books record the number of children attending the school at the institution each day. No children's names are recorded.
Searches books	On occasions, children were searched. This register records the name of the child, the type of search, reason for search, who carried out the search and who authorised the search.
Seclusion books	When children were placed in seclusion, staff would report on the child for each shift. The reports include the name of the child, the room they were in, reason for seclusion. Each report was signed and witnessed, and was also signed by a doctor.
Section report/ Sisters report books	At the end of each shift, staff would record information in these books about each child in a section including medical issues and medication, and a brief description of their behaviour and activities during that shift.
Self injuries	This provides a record of self injuries inflicted by residents.

Tantrum books	These books list the names of children who were punished for misbehaviour, the nature of their behaviour, the nature and time frame of the punishment and the name of the staff members who administered and witnessed the punishment.
Time out books	Young people were placed in 'time out' situations when they had misbehaved. These books record the name of the child and the time in and out, and a signature of a staff member.
Treatment/injuries books	The name of the child, date and details of injury are recorded in these books.
Visitors books	These record the name and address of visitors and who they came to see and when.
Weekly returns	Each institution was required to let the Brisbane office know who had been admitted to or discharged from the institution during each week. The forms that record this information list the number of children in the institution at the beginning of the week, the names of children that came or left, and the total number of children at the end of the week.
Youth workers, training workers logs, books	These log books record the name of the child and the date and time of the activity/event.



# Non-Government Institutions

## RECORDS OF NON-GOVERNMENT INSTITUTIONS

When examining the records kept by the institutions run by the non-government sector, it is important to remember that there were very few legislative requirements or guidelines for the types of records that should be kept. Legislation required all institutions to keep an admission register and punishment books. But there was no requirement that they be kept indefinitely.

It is not possible to say what records were routinely maintained by institutions or what variations there were in record keeping practices between different institutions. However, it is known that not many records have survived.

The Department has been advised by non-government service providers that few records have been systematically retained. The majority of records that do exist are summary records such as admission registers. Where client files do exist, they relate to more recent residents. For many institutions, there are no client records at all.

There has never been any legislative requirement for the non-government sector to keep records indefinitely. In many cases, once a certain period of time had elapsed following a child's stay in the institution, their records were destroyed. Regrettably, it is very evident that not many records have been kept.

The non-government institutions are listed below in alphabetical order. An index at the end of this guide indicates the institutions operated by each church or community group.

There are many discrepancies in the records particularly with regard to the children's names eg the child's name is recorded in the Register but they are known by another Christian name or surname; similarly the same discrepancy occurs with date of birth, admission, discharge etc.

- There are 210 names in the school register that have been omitted from the admission register. These have been added to the computer files and date from 1930 to 1975.
- Because records for some periods are inaccurate and inadequate, there are errors and omissions.

Requests for personal information need to be made in writing. This information can be gained by anyone who is able to identify themselves as having a right to personal information. A computer print-out is available of all information recorded from the books of original entry. Physical access to the records is not available due to their fragility and the need to protect the privacy of others.

# Legislation Milestones

In 1979 the then Department of Children's Services produced an historical overview of care for children in Queensland since 1879. This publication is now out of print, but can be viewed on the Department's web site at

The following provides a list of historical and legislative milestones since the early 1900s and provides some background to the operation of the State Children Department and the Departments that took over its responsibilities after 1966.

- 1905        The *Infant Life Protection Act* arranged for the registration of nursing homes for children under three, the reporting of the births and deaths of illegitimate children and for the adoption of these children. Such children had no inheritance rights in their adoptive family. This Act was administered by the Police Department until 1918.
- 1907        The *Children's Court Act* formed a special court of petty sessions specifically called a Children's Court, where charges were to be heard in camera for children under 17 years.
- 1911        Passing of the *State Children Act of 1911*, and the consequent repeal of the *Orphanages Act of 1879* and the *Reformatory and Industrial Schools Acts of 1865 to 1906*. The new Act consolidated and amended the whole law regarding children under State control and provided for the care of children up to 13 years. It established the State Children Department with a Director to replace the Inspector of Orphanages, and removed the administration of the orphanages from the Department of Public Instruction.
- 2 Jul 1912    Regulations under the *State Children Act of 1911* gazetted and came into force – changes included the scope of the definition of the term "Neglected child"; the committal by the Bench of a neglected or convicted child direct to the care of the

Department; the release of children either by the Bench or the Department on probation; the increase in the school age to 13 years and when necessary to 14 years; the keeping of certain girls under supervision till the age of 21 years was reached, and the power given to the Department to take action for maintenance against the parents or putative fathers of State children.

Age for discharge raised to 18 years “as a rule”

- 1917 Age for “hiring out” raised to 14 years (new school leaving age)
- The *State Children Amendment Act* raised from 13 to 14 years the age of children who received State benefits through their natural or foster mothers. If a State child gained a State Scholarship, maintenance and assistance lasted the term of the scholarship.
- 23 Oct 1918 The *Infant Life Protection Act Amendment Act of 1918* assented to, transferring the powers and duties of the Commissioner of Police to the Director, State Children Department – “the actual work was taken over from the Commissioner of Police on 1st November, 1918”
- 1921 The *Infant Life Protection Act* was amended providing legal adoption of children under 10 years, but gave adopted children no status or protection.
- 1935 The *Adoption of Children Act* (enacted 17 October 1935 – proclaimed 1 February 1936) provided for adoption of children to 21 years who had never been married and for rights of succession to the adoptive parents. It also provided a basis for sound adoption practices protecting the child, the natural parent and the adopting parents. The Director, State Children Department was empowered to make adoption orders, rather than adoption being a judicial process.
- 1964 The *Adoption of Children Act* repealed the earlier Acts in accordance with uniform adoption legislation throughout Australia. The Act states that the interests and welfare of the adopted child shall be regarded as the paramount consideration.
- 1965 The *Children’s Services Act* expressed the rights of all children to be reared, educated and protected by their parents and guardians but, should these rights be endangered, it empowered the State to ensure their well-being will be safe guarded.
- Feb 1965 School leaving age raised to 15 years and year 8 transferred to secondary school.
- 1 Aug 1966 The *Children’s Services Act of 1965* proclaimed.
- 1 March 1975 *Age of Majority Act of 1974* came into force lowering age of majority to 18 years
- 1975 *Commonwealth Family Law Act 1975* enacted
- 1978 The *Status of Children Act* declared all children to be of equal status.

- July 1980 The *Bail Act 1980*, which commenced on 1 July 1980, amended section 26 of the *Children's Services Act* pertaining to custody, remand and detention of children, in that a child may be granted bail in accordance with the Bail Act instead of a remand on bail subject to the Justices Act.
- 8 April 1987 Introduction of the *Young Offenders (Interstate Transfer) Bill* which provided for the transfer of young offenders to, from or through Queensland.
- 9 June 1987 Proclamation of sections of the *Family and Youth Services Act*, which replaced certain sections of the *Children's Services Act*.
- Dec 1990 Transition from Care Program established, in response to concerns raised by the *Report of the National Inquiry into Homeless Children (Burdekin Report)*.
- 19 Aug 1992 Enactment of the *Juvenile Justice Act 1992* (providing a new basis for the administration of juvenile justice, including a new range of sentencing options); and its companion Act the *Childrens Court Act 1992* (providing a framework for the structural reform of the Children's Court).
- 19 Nov 1992 *Freedom of Information Act 1992* provided members of the public with access to records held by the Department.
- 3 June 1993 Judge McGuire of the District Court appointed to the new position of Childrens Court Judge, and President of the Childrens Court of Queensland.
- 1 Sept 1993 Proclamation of the *Juvenile Justice Act 1992* and the *Childrens Court Act 1992* (see 19 August 1992 for further details).
- 26 Feb 1996 Responsibility for juvenile justice legislation and policy transferred to the Department of Justice.
- 24 Apr 1996 Responsibility for youth detention centres transferred to Queensland Corrective Services Commission.
- 20 Dec 1996 Proclamation of the *Children's Commissioner and Children's Services Appeals Tribunals Act 1996*, providing for the appointment of a Children's Commissioner and the establishment of the Children's Commission and Children's Services Appeals Tribunals.
- July 1998 Responsibility for youth justice legislation and policy returned to the Department of Families, Youth and Community Care.
- 7 Dec 1998 Responsibility for juvenile detention centres returned to the Department of Families, Youth and Community Care.
- March 1999 *Child Protection Act 1999* passed by Parliament
- 23 Mar 2000 Proclamation of the *Child Protection Act 1999*
